(the Bank and the Client are hereinafter collectively referred to as the "**Parties**" or individually as a "**Party**").

WHEREAS

The Client is the holder of the Accounts and wishes to use **myQuintet** and/or to allow the Client's Proxy (if any) to use **myQuintet** in relation to these Accounts. The Parties hereby intend to set out in this Agreement the conditions applicable to the access to and use of **myQuintet** by the Client and/or the Proxy (if any).

All capitalised terms used in these Specific Conditions and not defined in them are defined in the General Conditions of this Agreement.

IT IS AGREED AS FOLLOWS

1. ELECTRONIC SERVICES

1.1 The Bank shall provide the Client and/or the Proxy (if any) with myQintet, an Internet solution accessible via a website and a mobile application. Subject to any restrictions set forth in this Agreement and in the Annexes, myQintet allows the Client/or and the Proxy to use the following services:

- (a) access to and consultation of information on the Account;
- (b) receipt of correspondence and documents from the Bank; and
- (c) communication with the Bank via a secure messaging solution.

1.2 myQintet may also allow the Client and/or the Proxy (if any) to subscribe to new online services that may be offered by the Bank and to conclude agreements with the Bank in relation to such new online services.

1.3 Scope of service (only one choice possible)

- the Client requests the implementation of an access via myQintet for himself to all the existing accounts which he holds with the Bank and to all the services listed in Article 1;
- the Client requests the implementation of an access via myQintet for himself only to the Accounts listed in the table below and to all the services listed in Article 1 [indicate account numbers] :

1.4 If the Client wishes to grant access to myQintet to a Proxy, including any existing Proxy or agent, the Client shall fill in the Annex 1 attached hereto.

2. FINANCIAL TERMS

Use of myQintet by the Client and/or the Proxy (if any) is free of charge. However, the Bank reserves the right to charge for the access to and use of myQintet at any time and in accordance with its Tariff. Any decision of the Bank to charge for such access and use and any subsequent changes to the amounts charged by the Bank will be notified to the Client pursuant to the conditions and forms set out in the Tariff.

3. ENTRY INTO FORCE

- 3.1** This myQintet agreement shall enter into force on the date of the signature stipulated hereafter (the "Effective Date").
- 3.2** Where necessary, the Parties hereby agree that this myQintet agreement shall fully replace any previous agreement for the provision of electronic services signed between the same Parties, which shall be automatically cancelled.

4. ACCEPTANCE

By signing this Agreement, the Client declares having read, understood and accepted the myQintet General Conditions available through <https://www.qintet.lu/en-lu/myqintet>. In particular, the Client accepts all the clauses contained therein and declares that he/she has acknowledged Clause 17 (banking secrecy and data protection) of the myQintet General Conditions and expressly consents to the processing of information and data relating to him/her/it described in this Clause. Furthermore, the Client confirms having been informed that the latest version of the myQintet General Conditions is published on the Qintet website."
